11. OFFICERS AND REPS

11.1 Roles

- 11.1.1 There shall be five Full-Time Officers elected in accordance with the Articles of Association and these Bye-Laws. The roles shall be titled:
 - (a) President;
 - (b) Vice President (Arts, Law and Social Sciences);
 - (c) Vice President (Business);
 - (d) Vice President (Health, Social Care, Education and Medical Science); and
 - (e) Vice President (Science and Technology).
- 11.1.2 A Deputy President shall be nominated by the Faculty Voice Committee.
- 11.1.3 The Full-Time Officers shall be remunerated on a monthly basis by BACS in accordance with their terms and conditions of employment.
- 11.1.4 There shall be twelve part-time Campaign Reps elected in accordance with these Bye-Laws:
 - (a) Black and Minority Ethnic (BME) Students' Rep (Cambridge) and (Chelmsford);
 - (b) Disabled Students' Rep (Cambridge) and (Chelmsford);
 - (c) International Rep (Cambridge) and (Chelmsford);
 - (d) LGBT+ Students' Rep (Cambridge) and (Chelmsford);
 - (e) Trans* Trans Students' Rep (Cambridge) and (Chelmsford); and
 - (f) Womens' Rep (Cambridge) and (Chelmsford).
- 11.1.5 There shall be eleven part-time Faculty Reps elected in accordance with these Bye-Laws:
 - (a) ALSS Faculty Rep (Cambridge) and (Chelmsford);
 - (b) FHSCE Faculty Rep (Cambridge), (Chelmsford) and (Peterborough);
 - (c) FMS Faculty Rep (Cambridge) and (Chelmsford);
 - (d) FST Faculty Rep (Cambridge) and (Chelmsford); and
 - (e) LAIBS Faculty Rep (Cambridge) and (Chelmsford).
- 11.1.6 There shall be five part-time National Conferences Delegates elected in accordance with these Bye-Laws.
- 11.1.7 There shall be two part-time Postgraduate Research Reps elected for each faculty at Anglia Ruskin University in accordance with these Bye-Laws.

11.2 Duties

- 11.2.1 The duties of all Full-Time Officers, Campaign Reps, Faculty Reps and Postgraduate Research Reps shall include to:
 - (a) represent students; attend and support all democratic meetings and gather student views, opinions, ideas and feedback;
 - (b) work in the direction of the vision, mission, values and strategic priorities of the Students' Union;
 - (c) work to maximise communication with students;
 - (d) encourage participation in Union activities, in particular act as a champion for meetings, elections and campaigns;
 - (e) represent individuals, groups and the body of students to the University, National Union of Students, community and policy forming bodies, including attending meetings of such organisations;
 - (f) champion liberation, equality, diversity and inclusion;
 - (g) attend training courses and other opportunities for personal and professional development;
 - (h) attend meetings as appropriate to plan activities and review progress; and
 - (i) comply with all regulations, policies and protocols of the Union.
- 11.2.2 The duties of all Full-Time Officers shall include; to
 - (a) act as an Officer Trustee and member of the Board of Trustees with ultimate responsibility for directing the affairs of the Union;
 - (b) act as a member of the Faculty Voice Committee and Liberation, Equality, Diversity and Inclusion Committee;
 - (c) lead priority campaigns to promote change for the benefit of students and support all campaigns organised by the Union;
 - (d) hold regular meetings with relevant members of the Vice Chancellor's Group and Corporate Management Team and attend other meetings with the University appropriate to the role; and
 - (e) work such hours and in locations required to satisfy the duties of the post to maximise benefit to students.

11.2.3 The responsibilities of the President shall include to:

- (a) chair, lead and coordinate the Faculty Voice Committee, providing day-to-day support for the Full-Time Officers championing accountability and communication;
- (b) act as the primary spokesperson and figurehead for the Union to the University;

- (c) chair the Board of Trustees with line management responsibility for the Chief Executive;
- (d) represent the Union at the annual National Union of Students National Conference;
- (e) lead on significant campaigns and projects, working closely with the Chief Executive and fulfil any other appropriate needs of the Union that are not covered by another Full-Time Officer;
- (f) act as the Student Governor on the University's Board of Governors and relevant sub-committees; and
- (g) act as the main point of contact with the National Union of Students.

11.2.4 The responsibilities of all Vice Presidents shall include to:

- (a) act as the lead representative for a faculty or faculties;
- (b) chair a regular Faculty Forum to gather views, opinions, ideas and feedback;
- (c) implement ideas and projects to improve the experience of students within the faculty or faculties;
- (d) lead and support all elected representatives and volunteers within the faculty or faculties and Union;
- (e) provide effective academic representation and prioritise the wider development of representation within the University;
- (f) prepare for and attend Faculty Board;
- (g) proactively campaign on matters relating to wellbeing and welfare (including but not limited to accommodation, belief, equal opportunities, housing, finance, safety and religion); and
- (h) champion the benefits and growth of co-curricular and extra-curricular activities and opportunities.
- 11.2.5 The responsibilities of all Campaign Reps shall include to:
 - (a) act as a member of the Liberation, Equality, Diversity and Inclusion Committee;
 - (b) lead campaign(s) to promote change to the benefit of students and support all campaigns organised by the Union;
- 11.2.6 The responsibilities of all Faculty Rep shall include to:
 - (a) act as a member of the Faculty Voice Committee;
 - (b) support all campaigns organised by the Union;
 - (c) attend and support a regular Faculty Forum to gather views, opinions, ideas and feedback;

- (d) implement ideas and projects to improve the experience of students within the faculty or faculties;
- (e) provide effective academic representation;
- (f) prepare for and attend Faculty Board and Faculty Quality Enhancement and Standards Subcommittee; and
- (g) act as a deputy for the relevant Vice President when appropriate.
- 11.2.7 The responsibilities of all National Conferences Delegates shall be to represent the Union at the annual National Union of Students National Conference.
- 11.2.8 The responsibilities of all Postgraduate Research Reps shall include to:
 - (a) support all campaigns organised by the Union;
 - (b) provide effective academic representation; and
 - (c) prepare for and attend Faculty Research Subcommittee.
